## 3. Purposes of processing

We only use your personal data for the following purposes:

- To provide the information, services or provisions you request (newsletter, commercial offer, contact form, job offer, etc.);
- To collect information to improve SEMEC's sites, services and products (in particular via cookies).

All processing operations carried out and their purposes are set out and can be consulted in the personal-data processing table provided in [Annex 1](#).

## 4. Legal basis for processing

Your personal data is only collected in the cases provided for by the regulations in force – specifically, the existence of a legitimate interest in the use of your data and your consent to its use.

In order to satisfy a legitimate interest, the data collected is only intended to improve and ensure the accessibility of our site, our services and our products. In any event, we always balance our legitimate interest in carrying out necessary and proportionate processing against your interests, rights and fundamental freedoms.

As these legal bases are distinct and specific to the processing in question, all processing carried out and their legal bases are set out and can be consulted in the personal-data processing table provided in [Annex 1](#).

We guarantee that only the data strictly necessary for the satisfaction of the purposes defined in [Article 3](#) are collected. As such, in the absence of a response from you when requested, the services and information requested may be affected.

## 5. Category of personal data processed

Depending on the purpose pursued and the services and products requested, we may be required to process different categories of personal data:

- Identification data (surname, first name, photograph);
- Contact details (email address, telephone);
- Data relating to professional career (CV, cover letter).
- Data related to your browsing on the site (cookies).

As the personal data processed is distinct and specific to the processing in question, all processing carried out is set out and can be consulted in the personal-data processing table provided in [Annex 1](#).

## 6. Recipients of personal data

We are the only recipients of your personal data. Said data, whether individual or aggregated, is never transmitted to any third party, notwithstanding the subcontractors we use to ensure the proper fulfilment of the purposes defined in Article 3. In this case, we guarantee and ensure full compliance with the regulations in force by these subcontractors.

Neither we nor our subcontractors sell your personal data.

## 7. Personal-data retention period

We retain your personal data only for the time strictly necessary for the purposes of collection as defined in [Article 3](#).

As the retention periods are distinct and specific to the data in question, all processing carried out and their retention periods are set out and can be consulted in the personal-data processing table provided in [Annex 1](#).

## 8. Protection of your personal data

We undertake to implement appropriate technical and organisational measures in accordance with the applicable legal provisions to protect your personal data from alteration, accidental or unlawful loss, use, disclosure or unauthorised access. These measures include, but are not limited to:

- Appointing a Data Protection Officer;
- Raising awareness of confidentiality requirements among all our employees;
- Securing access to our premises and IT platforms;
- Implementation of a general IT-security policy for the company;
- Securing the access, sharing and transfer of data;
- Stringent data-protection requirements when selecting our subcontractors and partners.

## 9. Rights regarding personal data

### 9.1. *User rights*

You have the following rights with regard to your personal data:

- **Right of access**: To obtain confirmation of the processing of personal data, as well as a certain amount of information regarding processing, it being understood in any case that this information is provided in this document.
- **Right to correction**: To obtain the correction of personal data when it is inaccurate or incomplete.
- **Right to deletion**: Also known as the "right to be forgotten" – to obtain the deletion of personal data when it is no longer necessary for the purposes for which it was collected or when the data subject objects to the processing of their personal data.
- **Right to restrict processing**: To restrict the processing of personal data when the data subject disputes its accuracy, when the retention period for personal data has expired but the data subject still requires the retention of said personal data for the establishment, exercise or defence of a legal right, or if the data subject has objected to its processing.
- **Right to portability**: To obtain the communication of personal data that the data subject has communicated in a readable format, or to ask SEMEC to transmit the personal data communicated by the data subject to another controller.

- **Right to object:** To object, at any time, to the processing of personal data, on grounds relating to the data subject's personal situation, in particular in the event that this objection concerns commercial prospecting, including profiling.
- **Withdrawal of consent:** To withdraw consent to the future processing of personal data by SEMEC, where processing is based on consent.

## 9.2. *Conditions of exercise*

In accordance with Article 12 of the GDPR, and as a result of our obligation of security and confidentiality in the processing of your personal data, your request will be processed as long as you provide proof of your identity, in particular by producing a double-sided scan of your valid identity document. This proof of identity will be immediately destroyed after said right is exercised.

In any case, an email will be sent to you to confirm that your request has been received. This will be processed within a maximum of one month.

Furthermore, you may unsubscribe from our electronic communications at any time via the options available within these deliveries.

## 10. Complaint to the CNIL (French Data-Protection Agency)

If, despite our efforts to preserve the confidentiality of your personal data, you feel that your rights have not been respected, you have the right to lodge a complaint with the French Data-Protection Agency (CNIL).
